

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Ratifying FY 2020 Schuk Toak District Investment Budget)**

**DEFEATED
RESOLUTION NO. 20-332**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**
3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the Tohono**
5 **O'odham Council. The management of these funds shall be only by a treasurer or**
6 **other authorized officer of the district council who has furnished a surety bond**
7 **satisfactory to the treasurer of the Tohono O'odham Nation, and all expenditures**
8 **of these funds shall be by checks signed by such treasurer or other authorized**
9 **officer and the chairman or vice chairman of the district council.**

11 **WHEREAS, during discussions with the Budget and Finance Committee, the Schuk Toak**
12 **District informed the Committee that the District used investment funds for**
13 **holiday bonuses and gifts after approval of Schuk Toak District Council**
14 **Resolution Nos. ST-11-04-19-093 and ST-11-23-096; and**

15 **WHEREAS, by Schuk Toak District Council Resolution Nos. ST-11-04-19-093, ST-11-23-096,**
16 **and ST-08-12-20-53, the Schuk Toak District has authorized and submitted for**
17 **review and approval the FY 2020 Schuk Toak District Investment Budget, which is**
18 **incorporated by this reference, in the amount of \$104,257.38, for holiday bonuses**
19 **and gifts; and**

20 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2020 Schuk Toak District**
21 **Investment Budget and recommends its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council ratifies the FY**
23 **2020 Schuk Toak District Investment Budget in the amount of \$104,257.38.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 Schuk**
25 **Toak District Investment Budget shall be managed and expended in accordance**
26 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
27 **the Nation's laws, provided that any amendments or modifications shall be**
28 **authorized under District Council resolution and submitted for prior approval by**
29 **the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 04TH**
31 **day of AUGUST, 2020 at a meeting at which a quorum was present with a vote of 1,558.7 FOR;**
32 **1,617.0 AGAINST; -0- NOT VOTING and [02] ABSENT, pursuant to the powers vested in the Council**
33 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
34 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
