

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting September 29, 2020 Special Session to Address Tohono O'odham**  
**Nation Health Care CARES Act Budgets)**

LEGISLATIVE ORDER NO. 20-334

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and  
2 procedures to regulate all meetings of the Tohono O'odham Council, standing  
3 committees, boards and special committees." (Constitution of the Tohono  
4 O'odham Nation, Article VI, Section 1(a)); and


5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council  
6 with the authority to "by majority vote, call for a special session" (Legislative  
7 Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 WHEREAS, the Health and Human Services Committee has requested a special session on  
9 September 29, 2020 to address the Tohono O'odham Nation Health Care CARES Act  
10 budgets.

11 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a  
12 special session on September 29, 2020 to address the Tohono O'odham Nation  
13 Health Care CARES Act budgets.

14 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> day of  
15 SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;  
16 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
17 Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the  
18 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
20 18, 1934 (48 Stat.984).
