

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Education One Stop Division PY19/FY20 Budgets
Amendment No. 1)

RESOLUTION NO. 20-339

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Department of Education One Stop Division PY19/FY20 Budgets in the**
8 **amount of \$484,483.00 were approved by Resolution No. 19-204; and**

9 **WHEREAS, by Resolution No. 20-197, the Legislative Council approved Intergovernmental**
10 **Agreement Amendment No. 1 with the Arizona Department of Economic Security**
11 **to increase funding to the Tohono O'odham Nation One Stop Division in the**
12 **amount of \$620,269 for the time period beginning on July 1, 2019 through June 30,**
13 **2021; and**

14 **WHEREAS, with a recommendation from the Nation's Grants and Contracts Office, the**
15 **Department of Education prepared and submitted for review and approval its FY**
16 **2020 One Stop Division PY19/FY20 Budgets Amendment No. 1 effective July 1, 2019**
17 **through June 30, 2020; and**

18 **WHEREAS, the Department of Education has prepared and submitted for review and**
19 **approval its FY 2020 One Stop Division PY19/FY20 Budgets Amendment No. 1 as**
20 **follows:**

- 21 1. **PY19 Dislocated Worker, which includes a \$3,988.00 increase from**
22 **\$10,726.00 to \$14,714.00;**
- 23 2. **FY20 Dislocated Worker, which includes a \$18,974.00 increase from**
24 **\$50,787.00 to \$69,761.00;**
- 25 3. **PY19 Youth/Adult Admin, which includes a \$1,443.00 increase from \$5,469.00**
26 **to \$6,912.00;**
- 27 4. **PY19 Youth, which includes a \$56,456.00 increase from \$214,502.00 to**
28 **\$270,958.00;**
- 29 5. **FY20 Adult Admin, which includes a \$1,010.00 increase from \$3,726.00 to**
30 **\$4,736.00;**
- 31 6. **PY19 Adult, which includes a \$8,501.00 increase from \$31,588.00 to**

7. **FY20 Adult, which includes a \$45,414.00 increase from \$167,685.00 to \$213,099.00, and which are all incorporated by these references and which will adjust operational and/or personnel line items; and**

WHEREAS, the FY 2020 Department of Education One Stop Division PY19/FY20 Budgets Amendment No. 1 will increase the FY 2020 One Stop Division PY19/FY20 Budgets by \$135,786.00 from \$484,483.00 to \$620,269.00; and

WHEREAS, the Human Resources Development and Budget and Finance Committees have reviewed the FY 2020 Department of Education One Stop Division PY19/FY20 Budgets Amendment No. 1 and recommend their approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2020 Department of Education One Stop Division PY19/FY20 Budgets Amendment No. 1 effective July 1, 2019 through June 30, 2020, which includes a \$135,786.00 increase from \$484,483.00 to \$620,269.00.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2020 Department of Education One Stop Division PY19/FY20 Budgets as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2), 1(c)(2), and 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


