

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 20-237, "Approving FY 2020 Hewel Ni'ok KOHN Corporation  
for Public Broadcasting Community Service Grant CARES Stabilization Budget"  
to Extend the Budget Authority to September 30, 2021)**

**RESOLUTION NO. 20-381**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2020 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community**  
8 **Services Grant CARES Stabilization Budget in the amount of \$125,393.44 was**  
9 **approved by Resolution No. 20-237; and**

10 **WHEREAS, the budget authority under Resolution No. 20-237 expired on September 30, 2020,**  
11 **which makes it necessary to extend the budget authority to September 30, 2021 to**  
12 **expend available funds; and**

13 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**  
14 **amending resolution and recommend approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends**  
16 **Resolution No. 20-237 to extend the budget authority to September 30, 2021.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation chairperson or any designated official is authorized to administer and**  
19 **expend these funds for the period of October 1, 2020 through September 30, 2021,**  
20 **and the Accounting Department is authorized to post the unexpended balances**  
21 **of the budget as of September 30, 2020 as a carry forward into FY 2021 beginning**  
22 **October 1, 2020, provided that any amendments or modifications shall be**  
23 **submitted for prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
25 **day of NOVEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**  
26 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat.984).**


