

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Sells District Ge Oidag Community INT-01-14 Budget)**

**RESOLUTION NO. 20-385**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by**  
6 **a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

12 **WHEREAS, the FY 2020 Sells District Ge Oidag Community INT-01-14 Budget in the amount of**  
13 **\$6,615.00 was approved by Legislative Council Resolution No. 20-060; and**

14 **WHEREAS, by Sells District Council Resolution No. SD-111-20, the Sells District has**  
15 **authorized and submitted for review and approval the FY 2021 Sells District Ge**  
16 **Oidag Community INT-01-14 Budget, which is incorporated by this reference, in**  
17 **the amount of \$6,615.00 to be funded by FY 2020 Sells District Ge Oidag**  
18 **Community INT-01-14 Budget carryover funds; and**

19 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Sells District Ge**  
20 **Oidag Community INT-01-14 Budget and recommends its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2021 Sells District Ge Oidag Community INT-01-14 Budget in the amount of**  
23 **\$6,615.00 effective October 1, 2020 that shall be funded by FY 2020 Sells District Ge**  
24 **Oidag Community INT-01-14 Budget carryover funds.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Sells**  
26 **District Ge Oidag Community INT-01-14 Budget shall be managed and expended**  
27 **in accordance with Article IX, Section 7 of the Constitution of the Tohono**  
28 **O'odham Nation and the Nation's laws, provided that any amendments or**  
29 **modifications shall be authorized under District Council resolution and**  
30 **submitted for prior approval by the Tohono O'odham Legislative Council.**

31 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>**  
32 **day of NOVEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**  
33 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
34 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
35 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
36 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
37 **(48 Stat.984).**
