

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2021 Hickiwan District Coronavirus Aid, Relief and
Economic Security Act Budget)

RESOLUTION NO. 20-392

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS, by Resolution No. 20-226, the Legislative Council approved the FY 2021 Tohono**
13 **O'odham Nation Coronavirus Relief Fund Budget to be funded by the CARES Act**
14 **Coronavirus Relief Fund; and**

15 **WHEREAS, by Hickiwan District Council Resolution HDC-20-020, the Hickiwan District has**
16 **authorized and submitted the FY 2021 Hickiwan District Coronavirus Aid, Relief**
17 **and Economic Security Act Budget, which is incorporated by this reference in the**
18 **amount of \$652,700.00; and**

19 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Hickiwan District**
20 **CARES Act Budget and recommends its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2021 Hickiwan District CARES Act Budget effective March 13, 2020 through**
23 **December 30, 2020 in the amount of \$652,700.00, which shall be funded by the FY**
24 **2021 Tohono O'odham Nation Coronavirus Relief Fund Budget.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Hickiwan**
26 **District CARES Act Budget shall be managed and expended in accordance with**
27 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**
28 **Nation's laws, provided that any amendments or modifications shall be**
29 **authorized under District Council resolution and submitted for prior approval by**
30 **the Tohono O'odham Legislative Council.**

31 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH**
32 **day of NOVEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
33 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
34 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
35 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
36 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
37 **(48 Stat.984).**
