

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Executive Branch Bureau of Indian Affairs COVID-19 Budget)**

**RESOLUTION NO. 20-401**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**  
8 **2021 Bureau of Indian Affairs COVID-19 Budget, which is incorporated by this**  
9 **reference, in the amount of \$2,701,890.00 to be funded by the Bureau of Indian**  
10 **Affairs; and**

11 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Executive Branch**  
12 **Bureau of Indian Affairs COVID-19 Budget and recommends its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
14 **FY 2021 Executive Branch Bureau of Indian Affairs COVID-19 Budget effective**  
15 **March 1, 2020 through September 30, 2021 in the amount of \$2,701,890.00, which**  
16 **shall be funded by the Bureau of Indian Affairs.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation chairperson or any designated official is authorized to administer and**  
19 **expend the FY 2021 Executive Branch Bureau of Indian Affairs COVID-19 Budget,**  
20 **provided that any amendments or modifications shall be submitted for prior**  
21 **approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>**  
23 **day of NOVEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**  
24 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
26 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat.984).**
