

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Natural Resources Duakag Ha'ic'u A:ga Budget)**

RESOLUTION NO. 20-411

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Natural Resources has prepared and submitted for review and
8 approval its FY 2021 Department of Natural Resources Duakag Ha'ic'u A:ga
9 Budget, which is incorporated by this reference, in the amount of \$95,000.00 to be
10 funded by donations from the Desert Diamond Casino; and


11 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the
12 FY 2021 Department of Natural Resources Duakag Ha'ic'u A:ga Budget and
13 recommend its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
15 donation from the Desert Diamond Casino and approves the FY 2021 Department
16 of Natural Resources Duakag Ha'ic'u A:ga Budget effective October 1, 2020 in the
17 amount of \$95,000.00, which shall be funded by donations from the Desert
18 Diamond Casino.

19 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
20 Nation chairperson or any designated official is authorized to administer and
21 expend the FY 2021 Department of Natural Resources Duakag Ha'ic'u A:ga Budget,
22 provided that any amendments or modifications shall be submitted for prior
23 approval by the Tohono O'odham Legislative Council.

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
25 **day of DECEMBER, 2020 at a meeting at which a quorum was present with a vote of 2,745.15 FOR;**
26 **430.55 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**
27 **by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted**
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
30 **Act of June 18, 1934 (48 Stat.984).**


