

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Planning and Economic Development Department Roads  
Program Road Safety Assessment for BIA Route 15 Budget)**

**RESOLUTION NO. 20-429**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Planning and Economic Development Department has prepared and**  
8 **submitted for review and approval its FY 2021 Roads Program Road Safety**  
9 **Assessment for BIA Route 15 Budget, which is incorporated by this reference, in**  
10 **the amount of \$102,300.00 to be funded from the Nation's general fund pending**  
11 **reimbursement from the grantor, the Bureau of Indian Affairs; and**

12 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**  
13 **have reviewed the FY 2021 Planning and Economic Development Department**  
14 **Roads Program Road Safety Assessment BIA Route 15 Budget and recommend its**  
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2021 Planning and Economic Development Department Roads Program Road**  
18 **Safety Assessment BIA Route 15 Budget effective October 1, 2020 in the amount of**  
19 **\$102,300.00, which shall be funded by the Nation's general fund pending**  
20 **reimbursement from the grantor, the Bureau of Indian Affairs as referenced in**  
21 **BIA WRO Master Contract A20AV01025.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
23 **Nation Chairperson or any designated official is authorized to administer and**  
24 **expend the FY 2021 Planning and Economic Development Department Roads**  
25 **Program Road Safety Assessment BIA Route 15 Budget, provided that any**  
26 **amendments or modifications shall be submitted for prior approval by the**  
27 **Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
29 **day of DECEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**  
30 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**


