

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Chukut Kuk District West Villages Community Budget Amendment No. 1)

RESOLUTION NO. 21-007

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021 Chukut Kuk District Budget in the amount of \$2,369,762.78 was
13 authorized by Chukut Kuk District Council Resolution No. 2020-24 and approved
14 by Legislative Council Resolution No. 20-316; and

15 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2020-36, the Chukut Kuk District
16 has prepared and submitted for review and approval its FY 2021 West Villages
17 Community Budget Amendment No. 1, which is incorporated by this reference
18 and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2021 West Villages Community Budget Amendment No. 1 will increase the
20 FY 2021 West Villages Community Budget by \$31,450.38 from \$40,000.00 to
21 \$71,450.38 and will also increase the FY 2021 Chukut Kuk District Budget from
22 \$2,369,762.78 to \$2,401,213.16; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Chukut Kuk District
24 West Villages Community Budget Amendment No. 1 and recommends its
25 approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
27 FY 2021 Chukut Kuk District West Villages Community Budget Amendment No. 1,
28 which includes a \$31,450.38 increase from \$40,000.00 to \$71,450.38 and increases
29 the FY 2021 Chukut Kuk District Budget from \$2,369,762.78 to \$2,401,213.16 that
30 shall be funded as follows:

- 31 1. FY 2014 Mining in the amount of \$2,986.39
- 32 2. FY 2016 Mining in the amount of \$3,254.15
- 33 3. FY 2020 Carryover in the amount of \$25,209.84

2 **Kuk District West Villages Community Budget as amended shall be managed and**
3 **expended in accordance with Article IX, Section 7 of the Constitution of the**
4 **Tohono O'odham Nation and the Nation's laws provided that any amendments or**
5 **modifications shall be authorized under District Council resolution and**
6 **submitted for prior approval by the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
8 **day of JANUARY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
10 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
11 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
12 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
13 **(48 Stat.984).**
