

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Sells District Kawulk Community INT-01-14 Budget)**

RESOLUTION NO. 21-009

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS, by Sells District Council Resolution No. SD-132-20, the Sells District has**
13 **authorized the FY 2021 Sells District Kawulk Community INT-01-14 Budget, which**
14 **is incorporated by this reference, in the amount of \$12,406.99; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Sells District Kawulk**
16 **Community INT-01-14 Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2021 Sells District Kawulk Community INT-01-14 Budget in the amount of**
19 **\$12,406.99 effective October 1, 2020 that shall be funded by FY 2020 Sells District**
20 **Cowlic Community INT-01-14 Budget carryover funds.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Sells**
22 **District Kawulk Community INT-01-14 Budget shall be managed and expended in**
23 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**
24 **Nation and the Nation's laws, provided that any amendments or modifications**
25 **shall be authorized under District Council resolution and submitted for prior**
26 **approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
28 **day of JANUARY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
33 **(48 Stat.984).**
