

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Baboquivari District Administration, Choulic Community,  
South Komelic Community Budget Amendments No. 1 and FY 2021  
Artesia\Little Tucson Community Building Project Budget)**

**RESOLUTION NO. 21-025**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

11 ; and

12 **WHEREAS,** by Legislative Council Resolution No. 20-228, the Legislative Council approved the  
13 August 2020 District Allocation in the amount of \$3,074,043.86 for the  
14 Baboquivari District; and

15 **WHEREAS,** the FY 2021 Baboquivari District Budgets in the amount of \$3,074,043.86 was  
16 authorized by Baboquivari District Council Resolution No. 2020-B-75 and  
17 approved by Legislative Council Resolution No. 20-315; and

18 **WHEREAS,** by the following Baboquivari District Council resolutions, the Baboquivari  
19 District has authorized and submitted for review and approval the following  
20 budget amendments:

- 21 1. by Baboquivari District Council Resolution No. 2020-B-103, the FY 2021  
22 Baboquivari District Choulic Community Budget Amendment No. 1, which  
23 increases the FY 2021 Baboquivari District Choulic Community Budget by  
24 \$180,017.50 from \$355,930.12 to \$535,947.62;
- 25 2. by Baboquivari District Council Resolution No. 2020-B-104, the FY 2021  
26 Baboquivari District South Komelic Community Budget Amendment No.  
27 1, which increases the FY 2021 Baboquivari District South Komelic  
28 Community Budget by \$26,800.00 from \$355,930.12 to \$382,730.12;
- 29 3. by Baboquivari District Council Resolution No. 2020-B-106, the FY 2021  
30 Baboquivari District Administration Budget Amendment No. 1, which  
31 decreases the FY 2021 Baboquivari District Administration Budget by  
32 \$42,906.55 from \$981,369.69 to \$938,463.14; and

1 **WHEREAS, all three budget amendments are incorporated by these references and will**  
2 **adjust operational and/or personnel line items; and**

3 **WHEREAS, by Baboquivari District Council Resolution No. 2020-B-105, the Baboquivari**  
4 **District has authorized and submitted for review and approval its FY 2021**  
5 **Baboquivari District Artesia\Little Tucson Community Building Project Budget**  
6 **which is incorporated by this reference, in the amount of \$704,390.96; and**

7 **WHEREAS, the FY 2021 Baboquivari District Administration, Choulic Community, and South**  
8 **Komelic Community Budget Amendments No. 1 and the FY 2021 Artesia\Little**  
9 **Tucson Community Building Project Budget will increase the FY 2021**  
10 **Baboquivari District Budgets by \$868,301.91 from \$3,074,043.86 to \$3,942,345.77;**  
11 **and**

12 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Baboquivari District**  
13 **Administration, Choulic Community, and South Komelic Community Budget**  
14 **Amendments No. 1 and the FY 2021 Artesia\Little Tucson Community Building**  
15 **Project Budget and recommend their approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
17 **effective October 1, 2020 the:**

- 18 **(1) FY 2021 Choulic Community Budget Amendment No. 1 which includes a**  
19 **\$180,017.50 increase from \$355,930.12 to \$535,947.62;**
- 20 **(2) FY 2021 South Komelic Community Budget Amendment No. 1 which**  
21 **includes a \$26,800.00 increase from \$355,930.12 to \$382,730.12;**
- 22 **(3) FY 2021 Baboquivari District Administration Budget Amendment No. 1**  
23 **which will include a \$42,906.55 decrease from \$981,369.69 to \$938,463.14;**  
24 **and**
- 25 **(4) FY 2021 Artesia\Little Tucson Community Building Project Budget in the**  
26 **amount of \$704,390.96, which shall be funded by the FY 2021 Baboquivari**  
27 **District Administration Budget Amendment No. 1 in the amount of**  
28 **\$42,906.55 and the FY 2020 Artesia\Little Tucson Community Building**  
29 **Project Budget carryover funds in the amount of \$661,484.41.**

30 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the FY 2021**  
31 **Baboquivari District Budgets are increased by a total of \$868,301.91 from**  
32 **\$3,074,043.86 to \$3,942,345.77.**

33 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021**  
34 **Baboquivari District Budgets as amended and the FY 2021 Artesia\Little Tucson**  
35 **Community Building Project Budget shall be managed and expended in**


1 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation and the Nation's laws, provided that any amendments or modifications  
3 shall be authorized under District Council resolution and submitted for prior  
4 approval by the Tohono O'odham Legislative Council.

5 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>  
6 day of JANUARY, 2021 at a meeting at which a quorum was present with a vote of 3.175.7 FOR; -0-  
7 AGAINST; [02] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
8 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
9 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
10 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
11 (48 Stat.984).


