

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Bureau of Indian Affairs Judicial Service P.L. 93-638
Budget Amendment No. 1)

RESOLUTION NO. 21-047

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Bureau of Indian Affairs Budgets Judicial Branch under the P.L. 93-**
8 **638 Master Contract was approved by Resolution No. 20-249 in the amount of**
9 **\$461,365.07; and**

10 **WHEREAS, the Judicial Branch has prepared and submitted for review and approval its FY**
11 **2021 Bureau of Indian Affairs ("BIA") Judicial Branch P.L. 93-638 Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**
13 **operational, personnel and/or capital line items; and**

14 **WHEREAS, the FY 2021 BIA Judicial Branch P.L. 93-638 Budget Amendment No. 1 will**
15 **decrease the FY 2021 BIA Judicial Branch P.L. 93-638 Budget's indirect cost**
16 **charges by \$37,964.98 from \$74,177.07 to \$36,212.09 and in turn decrease the**
17 **overall FY 2021 BIA Judicial Branch P.L. 93-638 Budget by \$37,964.98 from**
18 **\$461,365.07 to \$423,400.09; and**

19 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed the FY 2021 BIA**
20 **Judicial Branch P.L. 93-638 Budget Amendment No. 1 and recommend its**
21 **approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2021 Bureau of Indian Affairs Judicial Branch P.L. 93-638 Budget Amendment**
24 **No. 1 effective October 1, 2021, which includes a \$37,964.98 decrease from**
25 **\$461,365.07 to \$423,400.09.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chief Judge and**
27 **any designated official is authorized to administer and expend the FY 2021**
28 **Bureau of Indian Affairs Judicial Branch P.L. 93-638 Budget as amended,**
29 **provided that any modifications or amendments shall be submitted for prior**
30 **approval by the Tohono O'odham Legislative Council.**
