

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending FY 2021 San Xavier District Coronavirus Relief Program Budget
to Extend Time Period)**

RESOLUTION NO. 21-055

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021 San Xavier District Budget in the amount of \$8,784,825.35 was
13 authorized by San Xavier District Council Resolution No. SXDC 08-20-14 and
14 approved by Legislative Council Resolution No. 20-325; and

15 **WHEREAS,** the San Xavier District applied for and received grant funds from the Tohono
16 O'odham Nation's CARES Act Coronavirus Fund in the amount of \$1,277,292.11 to
17 fund COVID-19 matters affecting the San Xavier District Community for a period
18 of March 1, 2020 to December 30, 2020; and

19 **WHEREAS,** Congress extended the federal deadline for expending the Coronavirus Relief
20 Fund and by Resolution No. 21-018, the Legislative Council extended the time
21 period for utilizing the Tohono O'odham Nation's Coronavirus Relief Fund to
22 December 31, 2021; and

23 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 01-21-01, the San Xavier
24 District has authorized and submitted for review and approval its FY 2021 San
25 Xavier District Coronavirus Relief Program Budget time extension request,
26 which is incorporated by this reference; and

27 **WHEREAS,** the Budget and Finance Committee recommends amending the FY 2021 San
28 Xavier District Coronavirus Relief Program Budget to extend it through
29 December 31, 2021.

30 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council amends the
31 FY 2021 San Xavier District Coronavirus Relief Program Budget to extend budget
32 period from March 1, 2020 to December 31, 2021.

33 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 San
34 Xavier District Coronavirus Relief Program Budget, as amended shall be



1 managed and expended in accordance with Article IX, Section 7 of the
2 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that
3 any amendments or modifications shall be authorized under a District Council
4 resolution and submitted for prior approval by the Tohono O'odham Legislative
5 Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH
7 day of FEBRUARY, 2021 at a meeting at which a quorum was present with a vote of 3,081.2 FOR;
8 94.5 AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council
9 by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the
10 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12 18, 1934 (48 Stat.984).
