13	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving
14		membership and adoption applications misspelled or incorrectly listed the
15		names of members; and
16	WHEREAS,	the Enrollment Program recommends that Resolution Nos. 03-100, 03-280, and
17		05-472 be amended to reflect the correct names for the members identified in the
18		March 2021 Corrected Enrollment Resolution Summary, which is incorporated by
19		this reference.
