

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Division of
Behavioral Health SAMHSA COVID-19 Budget Amendment No. 1)

RESOLUTION NO. 21-126

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Health and Human Services Division of Behavioral
8 Health SAMHSA COVID-19 Budget in the amount of \$97,402.00 was approved by
9 Resolution No. 20-297; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2021 SAMHSA COVID-19 Budget Amendment No. 1,
12 which is incorporated by this reference and which will adjust operational and/or
13 personnel line items; and

14 **WHEREAS,** the FY 2021 Department of Health and Human Services Division of Behavioral
15 Health SAMHSA COVID-19 Budget Amendment No. 1 will not change the budget
16 amount of \$97,402.00; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2021 Department of Health and Human Services Division of
19 Behavioral Health SAMHSA COVID-19 Budget Amendment No. 1 and recommend
20 its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2021 Department of Health and Human Services Division of Behavioral Health
23 SAMHSA COVID-19 Budget Amendment No. 1 effective May 15, 2020, which will not
24 change the budget amount of \$97,402.00.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
26 Nation chairperson or any designated official is authorized to administer and
27 expend the FY 2021 Department of Health and Human Services Division of
28 Behavioral Health SAHMSA COVID-19 Budget as amended, provided that any
29 amendments or modifications shall be submitted for prior approval by the
30 Tohono O'odham Legislative Council.
