(Issuing Certificates of Election from the May 22, 2021 General Election for the Offices of
Representatives and Alternates to the Tohono O'odham Legislative Council and Seating Such
Elected Officials)

LEGISLATIVE ORDER NO. 21-168

1 **WHEREAS, on Saturday, May 22, 2021 the Tohono O'odham Election Board conducted a**
2 **general election for the offices of representatives and alternates to the Tohono**
3 **O'odham Legislative Council and district councils; and**
4 **WHEREAS, the Election Board issued and posted its Certificates of Election Results dated May**
5 **22, 2021, which is incorporated by this reference, in accordance with 12 T.O.C.**
6 **Chapter 1 - Elections, Section 1806(J); and**
7 **WHEREAS, Section 1808 of the Nation's Elections law requires that the Legislative Council**
8 **issue Certificates of Election to the persons who received the highest number of**
9 **votes for the offices of Legislative Council representative and alternate within 20**
10 **days after the Election Board has posted its Certificates of Election Results;**
11 **provided, however, that no election contest is pending for those offices and**
12 **further provided that a candidate holding another elective public office of the**
13 **Nation must resign before being seated; and**
14 **WHEREAS, the period for contesting the 2021 general election has expired and no such**
15 **contest has been filed in accordance with the requirements of Article IX of 12**
16 **T.O.C. Chapter 1 - Elections.**

17 **NOW, THEREFORE, BE IT ORDERED that the chairperson and secretary of the Tohono O'odham**
18 **Legislative Council are authorized and directed on behalf of the Council to**
19 **execute and deliver a certificate of election to each of the following persons**
20 **elected as representatives and alternates to the Tohono O'odham Legislative**
21 **Council; provided that all such persons shall hold office in accordance with the**
22 **Elections law, and that (1) the certificate of election and seating of a candidate**
23 **holding another elective public office of the Nation shall not be effective until the**
24 **candidate resigns such office and (2) the certificate of election and seating of a**
25 **candidate subject to a pending election contest shall not be effective until the**
26 **contest is decided and the election result is confirmed:**
