

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 15-80, 32-80, 115-82, 67-84, 99-039,  
02-042, 04-291, and 12-144 to Reflect Legal Name Changes of Enrolled Members)**

**LEGISLATIVE ORDER NO. 21-174**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws  
2 and ordinances governing the enrollment and adoption of members  
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and  
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the  
6 Enrollment Committee shall review membership applications and make a  
7 written recommendation to the Tohono O'odham Legislative Council to approve  
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment  
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono  
11 O'odham Legislative Council shall determine eligibility for membership or  
12 adoption; and

13 **WHEREAS,** the Enrollment Program has received official documents reflecting the legal  
14 name changes of enrolled members as a result of marriage, divorce, legal  
15 adoption, or for other reasons; and

16 **WHEREAS,** the Enrollment Program recommends that Resolution Nos. 15-80, 32-80, 115-82,  
17 67-84, 99-039, 02-042, 04-291, and 12-144 be amended to reflect the amended  
18 names for the members identified in the June 2021 Amended Enrollment  
19 Resolution Summary, which is incorporated by this reference.

20 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
21 Nos. 15-80, 32-80, 115-82, 67-84, 99-039, 02-042, 04-291, and 12-144 are amended  
22 upon the effective date of those resolutions to reflect the legal name changes of  
23 members identified in the June 2021 Amended Enrollment Resolution Summary.

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
25 **day of JUNE, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
27 **Article II, Section 1 and Section 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
28 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**  
29 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**  
30 **to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
