

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Division of Senior
Services Title VI Families First Coronavirus Budget Amendment No. 1)**

RESOLUTION NO. 21-199

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Health and Human Services ("DHHS") Division of
8 Senior Services Title VI Families First Coronavirus Budget in the amount of
9 \$62,270.00 was approved by Resolution No. 20-132; and

10 **WHEREAS,** the DHHS has prepared and submitted for review and approval its FY 2021
11 Division of Senior Services Title VI Families First Coronavirus Budget
12 Amendment No 1, which will adjust operational and/or personnel line items; and

13 **WHEREAS,** the FY 2021 DHHS Division of Senior Services Title VI Families First Coronavirus
14 Budget Amendment No. 1 will not change the budget amount of \$62,270.00; and

15 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
16 reviewed the FY 2021 DHHS Division of Senior Services Title VI Families First
17 Coronavirus Budget Amendment No. 1 and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2021 Department of Health and Human Services Division of Senior Services
20 Title VI Families First Coronavirus Budget Amendment No. 1 effective April 1,
21 2020, which does not change the budget amount of \$62,270.00.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2021 Department of Health and Human Services Division of Senior
25 Services Title VI Families First Coronavirus Budget as amended, provided that
26 any amendments or modifications shall be submitted for prior approval by the
27 Tohono O'odham Legislative Council.

28 **The foregoing** Resolution was passed by the Tohono O'odham Legislative Council on the 16TH
29 day of ~~JUNE, 2021~~ at a meeting at which a quorum was present with a vote of 3,001.4 FOR; -0-
30 AGAINST; -0- NOT VOTING; and 216.6 [02] ABSENT, pursuant to the powers vested in the Council
31 by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted
32 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
33 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
34 Act of June 18, 1934 (48 Stat.984).


