

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Division of Family
Assistance USDA Food Distribution Program Budget Amendment No. 1)**

RESOLUTION NO. 21-205

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Health and Human Services Division of Family
8 Assistance USDA Food Distribution Program Budget in the amount of \$399,126.00
9 was approved by Resolution No. 20-278; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2021 Division of Family Assistance USDA Food
12 Distribution Program Budget Amendment No. 1, which is incorporated by this
13 reference and which will adjust operational and/or personnel line items; and

14 **WHEREAS,** the FY 2021 Department of Health and Human Services Division of Family
15 Assistance USDA Food Distribution Program Budget Amendment No. 1 will
16 increase the FY 2021 Division of Family Assistance USDA Food Distribution
17 Program Budget by \$2,001.00 from \$399,126.00 to \$401,127.00; and

18 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
19 reviewed the FY 2021 Department of Health and Human Services Division of
20 Family Assistance USDA Food Distribution Program Budget Amendment No. 1 and
21 recommend its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
23 FY 2021 Department of Health and Human Services Division of Family Assistance
24 USDA Food Distribution Program Budget Amendment No. 1 effective October 1,
25 2020, which includes a \$2,001.00 increase from \$399,126.00 to \$401,127.00 that
26 shall be funded by the Nation's general fund pending reimbursement from the
27 United States Department of Agriculture (USDA).

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
29 Nation chairperson or any designated official is authorized to administer and
30 expend the FY 2021 Department of Health and Human Services Division of Family
31 Assistance USDA Food Distribution Program Budget as amended, provided that

any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH day of JUNE, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
