

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Memorandum of Understanding)**

RESOLUTION NO. 21-241

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**
2 **negotiate and conclude agreements and contracts on behalf of the Tohono**
3 **O'odham Nation with State and local governments...on all matters within the**
4 **authority of the Tohono O'odham Council" (Constitution of the Tohono O'odham**
5 **Nation, Article VI, Section 1(f)); and**

6 **WHEREAS, by Resolution No. 21-087, the Legislative Council affirmed its approval of the 2021**
7 **Tohono O'odham Nation-State of Arizona Gaming Compact amendments ("2021**
8 **Compact"), which were subsequently executed, approved by the United States**
9 **Department of the Interior Acting Assistant-Secretary-Indian Affairs, and**
10 **became effective on May 24, 2021; and**

11 **WHEREAS, the Nation also has entered new and amended 2021 Compact appendices and the**
12 **Commerce Committee and Nation's Chairman have reviewed amendments to the**
13 **2007 Memorandum of Understanding Regarding Poker Between the Tohono**
14 **O'odham Nation and the State of Arizona to provide for certain updated**
15 **definitions, operational standards, specifications, regulations, and other**
16 **provisions ("2021 Poker MOU").**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves, and**
18 **authorizes and directs the Nation's Chairman to execute, the 2021 Poker MOU,**
19 **which is incorporated by this reference and which shall supersede and replace**
20 **the 2007 Memorandum of Understanding Regarding Poker Between the Tohono**
21 **O'odham Nation and the State of Arizona.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
23 **day of JULY, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
24 **AGAINST; [03] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
28 **(48 Stat.984).**
