

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution No. 03-280, "Enrollment-June" to Add and  
Approve an Applicant Whose Name was not Included in the June 2003  
Approved Enrollment Application List)**

**RESOLUTION NO. 21-260**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws  
2 and ordinances governing the enrollment and adoption of members  
3 (Constitution of the Tohono O'odham Nation Article VI, Section 1(h)); and  
4 **WHEREAS,** Articles VI and VII of the Nation's Enrollment Ordinance provide that the  
5 Enrollment Committee is responsible for reviewing enrollment applications and  
6 making recommendations to the Legislative Council regarding the eligibility of  
7 applicants (Enrollment Ordinance, 14 Tohono O'odham Code Chapter 1); and  
8 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Legislative  
9 Council shall review applications for membership in the Nation "together with  
10 the recommendations of the Enrollment Committee, and determine whether the  
11 applicant is eligible for membership or adoption" and its final determination  
12 "shall be recorded in a Council resolution" (Enrollment Ordinance, 14 Tohono  
13 O'odham Code Chapter 1, Section 1(A)(1) and (C)); and  
14 **WHEREAS,** the Enrollment Program has determined that a member was recommended for  
15 approval by the Enrollment Committee and was given an enrollment number,  
16 however, the individual was not listed on Resolution No. 03-280 or in any other  
17 resolution approving membership; and  
18 **WHEREAS,** while all available documents and records show that the Enrollment Committee  
19 had reviewed and recommended approval of the enrollment application for the  
20 individual to be included on the June 2003 Approved Enrollment Application List,  
21 for unknown reasons, the name of the individual was not on the list of names  
22 approved by Resolution No. 03-280; and  
23 **WHEREAS,** the Enrollment Program therefore recommends that Resolution No. 03-280 be  
24 amended to add the member identified on the "Amendment to the June 2003  
25 Approved Enrollment Application List," which is incorporated by this reference.  
26 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
27 No. 03-280, "Enrollment-June" is amended upon the effective date of that  
28 resolution by adding the member's name and corresponding information into  
29 the "Amendment to the June 2003 Approved Enrollment Application List."
