

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2021 Planning and Economic Development Department Credit  
and Finance Program BIA P. L. 93-638 Budget Amendment No. 1)**

**RESOLUTION NO. 21-271**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Planning and Economic Development Department Credit and  
8 Finance Program BIA P.L. 93-638 Budget in the amount of \$303,581.47 was  
9 approved by Resolution No. 20-249; and

10 **WHEREAS,** the Planning and Economic Development Department has prepared and  
11 submitted for review and approval its FY 2021 Credit and Finance Program BIA  
12 P.L. 93-638 Budget Amendment No. 1, which is incorporated by this reference and  
13 which will adjust operational and/or personnel line items; and

14 **WHEREAS,** the FY 2021 Planning and Economic Development Department Credit and  
15 Finance Program BIA P.L. 93-638 Budget Amendment No. 1 will decrease the FY  
16 2021 BIA P.L. 93-638 Budget's indirect cost by \$20,493.23 from \$303,581.47 to  
17 \$283,088.24; and

18 **WHEREAS,** the Commerce and Budget and Finance Committees have reviewed the FY 2021  
19 Planning and Economic Development Department Credit and Finance Program  
20 BIA P.L. 93-638 Budget Amendment No. 1 and recommend approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
22 FY 2021 Planning and Economic Development Department Credit and Finance  
23 Program BIA P.L. 93-638 Budget Amendment No. 1 effective October 1, 2020, which  
24 includes a \$20,493.23 decrease in indirect costs from \$303,581.47 to \$283,088.24.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
26 Nation chairperson or any designated official is authorized to administer and  
27 expend the FY 2021 Planning and Economic Development Department Credit and  
28 Finance Program BIA P.L. 93-638 Budget as amended, provided that any  
29 amendments or modifications shall be submitted for prior approval by the  
30 Tohono O'odham Legislative Council.




