

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Natural Resources Range Conservation
and Management Program Budget Amendment No. 1)**

RESOLUTION NO. 21-276

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Department of Natural Resources Range Conservation and**
8 **Management Program Budget in the amount of \$743,388.25 was approved by**
9 **Resolution No. 20-249; and**

10 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
11 **approval its FY 2021 Range Conservation and Management Program Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2021 Department of Natural Resources Range Conservation and**
15 **Management Program Budget Amendment No. 1 will decrease the FY 2021 Range**
16 **Conservation and Management Program Budget by \$50,703.87 from \$743,388.25**
17 **to \$692,684.38; and**

18 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
19 **have reviewed the FY 2021 Department of Natural Resources Range Conservation**
20 **and Management Program Budget Amendment No. 1 and recommend its**
21 **approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2021 Department of Natural Resources Range Conservation and Management**
24 **Program Budget Amendment No. 1 effective October 1, 2020, which includes a**
25 **\$50,703.87 decrease from \$743,388.25 to \$692,684.38.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2021 Department of Natural Resources Range Conservation and**
29 **Management Program Budget as amended, provided that any amendments or**
30 **modifications shall be submitted for prior approval by the Tohono O'odham**
31 **Legislative Council.**
