

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Updated Negotiation Terms and Negotiating Team)**

RESOLUTION NO. 21-287

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the authority to “promote, protect and provide for public health, peace, morals,**
3 **education and general welfare of the Tohono O'odham Nation and its members”**
4 **(Constitution, Article VI, Section 1(c)(2)); and**

5 **WHEREAS, the Constitution of the Tohono O'odham Nation also vests the Legislative Council**
6 **with the authority to “consult, negotiate and conclude agreements and contracts**
7 **on behalf of the Tohono O'odham Nation with Federal, State and local**
8 **governments and other Indian tribes or their departments, agencies, or political**
9 **subdivisions, or with private persons or organizations on all matters within the**
10 **authority of the Tohono O'odham Council” (Constitution, Article VI, Section 1(f));**
11 **and**

12 **WHEREAS, by Resolution No. 20-331, the Legislative Council approved option one from a**
13 **closed session September 15, 2020 update and authorized the Office of the**
14 **Chairman and Vice Chairwoman to implement option one, provided that the**
15 **Office of the Chairman and Vice Chairwoman regularly update respective**
16 **oversight committees, the Legislative Council, and Traditional O'odham Leaders;**
17 **and**

18 **WHEREAS, by Resolution No. 20-441, the Legislative Council approved confidential**
19 **Negotiation Terms and authorized the Office of the Chairman and Vice**
20 **Chairwoman to continue negotiating with the appropriate parties in accordance**
21 **with the Negotiation Terms, provided that prior to any execution and finalization**
22 **of option one, the Office of the Chairman and Vice Chairwoman would confer with**
23 **the Legislative Council for further approval; and**

24 **WHEREAS, in the course of the negotiations, it has become necessary to update the**
25 **confidential Negotiation Terms, which are incorporated by this reference, and**
26 **which shall remain confidential until any agreement is reached; and**

27 **WHEREAS, the Committee recommends formally adding a member of the Committee to**
28 **participate with the Office of the Chairman and Vice Chairwoman in the**
29 **negotiations; and**

30 **WHEREAS, the Agricultural and Natural Resources Committee reviewed the Updated**
31 **Negotiation Terms and recommend approval.**

32 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 33 **1. Approves the Updated Negotiation Terms; and**


