

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Gu-Vo District Community Budget Amendment No. 1)**

RESOLUTION NO. 21-289

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the Chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** the FY 2021 Gu-Vo Community Budget in the amount of \$409,872.51 was
13 authorized by Gu-Vo District Council Resolution No. GV-20-044 and approved and
14 approved by the Legislative Council Resolution No. 20-318; and

15 **WHEREAS,** by Gu-Vo District Governing Council Resolution GV-21-033, the Gu-Vo District has
16 authorized and submitted for review and approval its FY 2021 Gu-Vo District
17 Community Budget Amendment No. 1, which is incorporated by these reference
18 and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2021 Gu-Vo District Community Budget Amendment No. 1 will not change
20 the FY 2021 Gu-Vo District Community Budget amount of \$409,872.51; and

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Gu-Vo District
22 Community Budget Amendment No. 1 and recommends approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 **FY 2021 Gu-Vo District Community Budget Amendment No. 1 effective October 1,**
25 **2020, which will not change the FY 2021 Gu-Vo District Community Budget**
26 **amount of \$409,872.51.**

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Gu-Vo
28 **District Budget, as amended shall be managed and expended in accordance with**
29 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**
30 **Nation's laws, provided that any amendments or modifications shall be**
31 **authorized under District Council resolution and submitted for prior approval by**
32 **the Tohono O'odham Legislative Council.**
