

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Department of Health and Human Services Self-Governance Budgets)**

**RESOLUTION NO. 21-295**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2022 Self-Governance Budgets for the period  
9 beginning October 1, 2021 and ending on September 30, 2022 (collectively "FY  
10 2022 Department of Health and Human Services Self-Governance Budgets"),  
11 which are provided below and incorporated by these references, in the total  
12 amount of \$8,798,989.50 to be funded by the Self-Governance Funding  
13 Agreement; and

14 **WHEREAS,** the following base budgets in the amount of \$8,798,989.50 have been prepared as  
15 follows:

25 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
26 reviewed the FY 2022 Department of Health and Human Services Self-Governance  
27 Budgets and recommend their approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
29 FY 2022 Department of Health and Human Services Self-Governance Budgets  
30 effective October 1, 2021 in the total amount of \$8,798,989.50, which shall be  
31 funded by the Self-Governance Funding Agreement.


32 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
33 O'odham Nation chairperson or any designated official is authorized to negotiate

1 and execute amendments to the Self-Governance Funding Agreement with the  
2 Indian Health Service for the maximum allowable funding.


3 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
4 Nation chairperson or any designated official is authorized to administer and  
5 expend the FY 2022 Department of Health and Human Services Self-Governance  
6 Budgets, provided that any amendments or modifications shall be submitted for  
7 prior approval by the Tohono O'odham Legislative Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>  
9 day of SEPTEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;  
10 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
11 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
12 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
13 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
14 18, 1934 (48 Stat.984).
