

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Planning and Economic Development Department Roads Program
PIR 400(1) San Lucy Design Street Lights and Sidewalks Project Budget)**

RESOLUTION NO. 21-330

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** by Resolution No. 16-346, the Legislative Council approved the FY 2017 Planning
8 and Economic Development Department, Roads Program San Lucy Community
9 Design and Construction of Sidewalks and Street Lights Budget in the amount of
10 \$186,020.29; and

11 **WHEREAS,** the Bureau of Indian Affairs Western Region Office awarded the Nation a no-cost
12 extension for the design and construction of San Lucy Design Street Lights and
13 Sidewalks Project, Project No. PIR 400(1), to September 30, 2023; and

14 **WHEREAS,** the Planning and Economic Development Department has prepared and
15 submitted for review and approval its FY 2022 Roads Program PIR 400(1) San Lucy
16 Design Street Lights and Sidewalks Project Budget, which is incorporated by this
17 reference, in the amount of \$117,174.68 to be funded by the Nation's general fund
18 pending reimbursement by the grantor, the Bureau of Indian Affairs; and

19 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
20 have reviewed the FY 2022 Planning and Economic Development Department
21 Roads Program PIR 400(1) San Lucy Design Street Lights and Sidewalks Project
22 Budget and recommend its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 FY 2022 Planning and Economic Development Department Roads Program PIR
25 400(1) San Lucy Design Street Lights and Sidewalks Project Budget effective
26 October 1, 2021 through September 30, 2023 in the amount of \$117,174.68, which
27 shall be funded by the Nation's general fund pending reimbursement by the
28 grantor, the Bureau of Indian Affairs.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
30 Nation chairperson or any designated official is authorized to administer and
31 expend the FY 2022 Planning and Economic Development Department Roads
32 Program PIR 400(1) San Lucy Design Street Lights and Sidewalks Project Budget,


