

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of the Bureau of Indian Affairs Grant Award and Approving FY 2022
Bureau of Indian Affairs Allocated School Bus Road Maintenance Project Budget)**

RESOLUTION NO. 21-389

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, on July 30, 2019, the Nation applied for a \$10,000 grant from the U.S. Bureau of**
8 **Indian Affairs ("BIA") in order to perform routine road maintenance on BIA-**
9 **owned roads located throughout the Nation; and**

10 **WHEREAS, the Tohono O'odham Nation was notified of the Grant Award, Contract No.**
11 **A20AV00154, in the amount of \$61,227.69 from the U.S. Bureau of Indian Affairs**
12 **("BIA"), effective October 1, 2019 through September 30, 2022; and**

13 **WHEREAS, the Planning and Economic Development Department has prepared and**
14 **submitted for review and approval its FY 2022 BIA Allocated School Bus Road**
15 **Maintenance Project Budget, which is incorporated by this reference, in the**
16 **amount of \$61,227.69; and**

17 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
18 **have reviewed the Bureau of Indian Affairs Grant Award and the FY 2022 BIA**
19 **Allocated School Bus Road Maintenance Project Budget and recommend**
20 **approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**
22 **Bureau of Indian Affairs Grant Award in the amount of \$61,227.69, effective**
23 **October 1, 2019 through September 30, 2022, and approves the FY 2022 BIA**
24 **Allocated School Bus Road Maintenance Project Budget in the amount of**
25 **\$61,227.69 effective October 1, 2021, that shall be funded by the Nation's general**
26 **fund pending reimbursement from the grantor, the Bureau of Indian Affairs.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend FY 2022 BIA Allocated School Bus Road Maintenance Project Budget,**
30 **provided that any amendments or modifications shall be submitted for prior**
31 **approval by the Tohono O'odham Legislative Council.**
