

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Attorney Contracts for the Office of Attorney General)**

**RESOLUTION NO. 21-394**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**  
2 **the power to "employ legal counsel for the protection and advancement of the**  
3 **rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**  
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General has prepared and submitted for review and**  
6 **approval its FY 2022 Attorney Contracts ("Attorney Contracts") with eleven firms,**  
7 **for the purposes and for the amounts indicated in attached Exhibit A; and**

8 **WHEREAS, fees for services for these eleven Attorney Contracts will be paid by the FY 2022**  
9 **Office of Attorney General Budget; and**

10 **WHEREAS, the Domestic Affairs Committee has reviewed the eleven FY 2022 Attorney**  
11 **Contracts and recommends approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 13 **1. Approves the eleven Attorney Contracts for FY 2022 for the Office of Attorney**  
14 **General, which shall be funded by the FY 2022 Office of the Attorney General**  
15 **Budget and shall be effective from October 1, 2021 to September 30, 2022.**
- 16 **2. Authorizes the Tohono O'odham Nation chairperson to execute the eleven**  
17 **Attorney Contracts in substantially the form attached.**
- 18 **3. Authorizes the Chairman of the Nation or any designated official to**  
19 **administer the eleven Attorney Contracts, provided that any amendments or**  
20 **modifications shall be submitted for prior approval by the Tohono O'odham**  
21 **Nation Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
23 **day of OCTOBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**  
24 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,**  
25 **Article VI Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
28 **(48 Stat.984).**
