

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 282-87 to Reflect the Legal Name Change
of One Enrolled Member)**

RESOLUTION NO. 21-446

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making recommendations to the Legislative Council regarding the eligibility of**
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
10 **O'odham Legislative Council shall determine whether an application is approved**
11 **for membership and its determination, along with the resolution number and**
12 **date of enactment, shall be provided to the applicant; and**

13 **WHEREAS, the Enrollment Program has received the official document showing the legal**
14 **name change of one enrolled member due to marriage, divorce, legal adoption,**
15 **or for other reasons; and**

16 **WHEREAS, the Enrollment Program recommends that Resolution No. 282-87 be amended to**
17 **reflect the amended name for the member identified in the December 2021**
18 **Amended Enrollment Resolution Summary, which is incorporated by this**
19 **reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **No. 282-87 is amended upon the effective date of the resolution to reflect the legal**
22 **name change for the member identified in the December 2021 Amended**
23 **Enrollment Resolution Summary.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
25 **day of DECEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
26 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,**
27 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
28 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
30 **16 of the Act of June 18, 1934 (48 Stat.984).**
