

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Education Higher Education Services
Budget Amendment No. 1)**

RESOLUTION NO. 21-452

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2022 Department of Education Higher Education Services Budget in the**
8 **amount of \$923,787.85 was approved by Resolution No. 21-293; and**

9 **WHEREAS, the Department of Education has prepared and submitted for review and**
10 **approval its FY 2022 Higher Education Services Budget Amendment No. 1, which**
11 **is incorporated by this reference and which will adjust operational and/or**
12 **personnel line items; and**

13 **WHEREAS, the FY 2022 Department of Education Higher Education Services Budget**
14 **Amendment No. 1 will increase the FY 2022 Higher Education Services Budget by**
15 **\$100,575.00 from \$923,787.85 to \$1,024,362.85; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
17 **reviewed the FY 2022 Department of Education Higher Education Services Budget**
18 **Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2022 Department of Education Higher Education Services Budget Amendment**
21 **No. 1 effective October 1, 2021, which includes a \$100,575.00 increase from**
22 **\$923,787.85 to \$1,024,362.85 that shall be funded by FY 2021 Department of**
23 **Education Higher Education Services Budget carry forward funds.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2022 Department of Education Higher Education Services Budget**
27 **as amended, provided that any amendments or modifications shall be submitted**
28 **for prior approval by the Tohono O'odham Legislative Council.**


