

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 20-381, "Approving FY 2020 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community Service Grant CARES Stabilization Budget" to Extend the Budget Authority until Funds are Fully Expended)

RESOLUTION NO. 21-457

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2020 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community**
8 **Services Grant CARES Stabilization Budget in the amount of \$125,393.44 was**
9 **approved by Resolution No. 20-237, and subsequently amended by Resolution No.**
10 **20-381 extending the budget authority to September 30, 2021; and**

11 **WHEREAS, the Corporation for Public Broadcasting ("CPB"), in granting these funds to the**
12 **Tohono O'odham Nation ("Nation") on behalf of Hewel Ni'ok, provided that the**
13 **funds granted are not subject to CPB's statutory funding allocations, are**
14 **considered unrestricted, and have no expenditure period; and**

15 **WHEREAS, the Nation has adopted a memorandum outlining the process for authorizing**
16 **multi-year awards, the memorandum dated July 16, 2021 is attached and**
17 **incorporated into this resolution, and would govern the budget authority for use**
18 **of the CPB CSG CARES Stability grant until fully expended; and**

19 **WHEREAS, at the end of fiscal year 2021, funds from the grant remain available to provide**
20 **continued service; and**

21 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed**
22 **this resolution and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends**
24 **Resolution No. 20-381 to extend the budget authority into FY 2022 and into**
25 **subsequent fiscal years until the funds are fully expended.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend these funds from October 1, 2019 until the grant funds are fully expended,**
29 **and the Accounting Department is authorized to post the unexpended balances**
30 **of the budget as of September 30, 2021 as a carry forward into fiscal year 2022**
31 **beginning October 1, 2021 and then thereafter into subsequent fiscal years until**
32 **the grant funds are fully expended, provided that any amendments or**



2 **Legislative Council.**




