

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Division of
Senior Services Title VI OAA American Rescue Plan Budget)**

RESOLUTION NO. 22-019

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services ("DHHS") has prepared and
8 submitted for review and approval its FY 2022 Division of Senior Services Title VI
9 OAA American Rescue Plan Budget, which is incorporated by this reference, in the
10 amount of \$96,480.00 to be funded by the Nation's general fund pending
11 reimbursement from the grantor, the United States Department of Health and
12 Human Services Administration for Community Living; and

13 **WHEREAS,** the granting agency has awarded the project for a three-year period beginning
14 May 1, 2021 and ending September 30, 2024, and the Department of Health and
15 Human Services has prepared the FY 2022 Department of Health and Human
16 Services Division of Senior Services Title VI OAA American Rescue Plan Budget to
17 expend funds for the budget period to provide continued services; and

18 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
19 reviewed the FY 2022 DHHS Division of Senior Services Title VI OAA American
20 Rescue Plan Budget and recommend approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2022 Department of Health and Human Services Division of Senior Services
23 Title VI OAA American Rescue Plan Budget effective May 1, 2021 through
24 September 30, 2024 in the amount of \$96,480.00, which shall be funded by the
25 Nation's general fund pending reimbursement from the grantor, the United
26 States Department of Health and Human Services Administration for Community
27 Living.

28 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Department of
29 Health and Human Services Division of Senior Services Title VI OAA American
30 Rescue Plan Budget is authorized to utilize funding for the three-year project
31 period ending September 30, 2024 or until the grant funds are fully expended to
32 provide continued services.



5 **amendments or modifications shall be submitted for prior approval by the**
6 **Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
8 **day of JANUARY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
10 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
11 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
13 **18, 1934 (48 Stat.984).**
