

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Pisinemo District Dirtburn Community Budget Amendment No. 1)

RESOLUTION NO. 22-034

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2022 Pisinemo District Gaming Distribution Budget in the amount of
13 \$4,288,132.28 was authorized by Pisinemo District Council Resolution No. 21-P-
14 43 and approved by Legislative Council Resolution No. 21-369; and

15 **WHEREAS,** by Pisinemo District Council Resolution No. 22-P-04, the Pisinemo District has
16 authorized and submitted for review and approval its FY 2022 Pisinemo District
17 Dirtburn Community Budget Amendment No. 1, which is incorporated by this
18 reference and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2022 Pisinemo District Dirtburn Community Budget Amendment No. 1 will
20 not change the budget amount of \$4,288,132.28; and

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022 Pisinemo District
22 Dirtburn Community Budget Amendment No. 1 and recommends its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 FY 2022 Pisinemo District Dirtburn Community Budget Amendment No. 1
25 effective October 1, 2021, which does not change the budget amount of
26 \$4,288,132.28.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2022 Pisinemo
28 District Gaming Distribution Budget, as amended shall be managed and
29 expended in accordance with Article IX, Section 7 of the Constitution of the
30 Tohono O'odham Nation and the Nation's laws, provided that any amendments or
31 modifications shall be authorized under District Council resolution and
32 submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH day of JANUARY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
