

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Natural Resources Duakag Ha'icu A:ga Budget)**

RESOLUTION NO. 22-062

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
8 **approval its FY 2022 Duakag Ha'icu A:ga Budget, which is incorporated by this**
9 **reference, in the amount of \$146,313.18 to be funded from donations and**
10 **contributions; and**


11 **WHEREAS, the Cultural Preservation and Budget and Finance Committee have reviewed the**
12 **FY 2022 Department of Natural Resources Duakag Ha'icu A:ga Budget and**
13 **recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2022 Department of Natural Resources Duakag Ha'icu A:ga Budget effective**
16 **October 1, 2021 in the amount of \$146,313.18, which shall be funded from**
17 **donations and contributions.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to administer and**
20 **expend the FY 2022 Department of Natural Resources Duakag Ha'icu A:ga Budget,**
21 **provided that any amendments or modifications shall be submitted for prior**
22 **approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
24 **day of FEBRUARY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
25 **-0- AGAINST; [01] NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,**
26 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat.984).**
