

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Judicial Branch American Rescue Plan Act Budget)**

RESOLUTION NO. 22-070

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 21-292, Adopting**
8 **the Tohono O'odham Nation American Rescue Plan Act ("ARPA") Allocation Plan;**
9 **and**

10 **WHEREAS, the ARPA Allocation Plan included \$22,432,001.00 for the Tohono O'odham**
11 **Judicial Branch; and**

12 **WHEREAS, ARPA allows for premium pay for employees performing essential work during**
13 **the COVID-19 public health emergency; and**

14 **WHEREAS, the Judicial Branch is requesting premium pay for Judicial employees retroactive**
15 **to March 11, 2021; and**

16 **WHEREAS, ARPA requires the funds to be obligated by December 31, 2024 and gives an**
17 **additional two years for completion of projects/delivery of services by December**
18 **31, 2026; and**

19 **WHEREAS, the Judicial Branch is requesting to expend funds from the Judicial Branch**
20 **American Rescue Plan Act budget until December 31, 2024; and**

21 **WHEREAS, the Judicial Branch has prepared and submitted for review and approval its FY**
22 **2022 American Rescue Plan Act Budget, which is incorporated by this reference,**
23 **in the amount of \$22,432,001.00 to be funded by ARPA Funds; and**

24 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed the FY 2022**
25 **Judicial Branch American Rescue Plan Act Budget and recommend its approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
27 **FY 2022 Judicial Branch American Rescue Plan Act Budget effective October 1,**
28 **2021 in the amount of \$22,432,001.00, which shall be funded by ARPA funds.**


29 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Judicial Branch**
30 **is authorized to continue expending funds from the FY 2022 Judicial Branch**
31 **American Rescue Plan Act Budget until December 31, 2024.**

1 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Judicial Branch
2 is authorized under the FY 2022 ARPA Budget to utilize premium pay retroactive
3 to March 11, 2021.


4 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Chief Judge and
5 any designated official is authorized to administer and expend the FY 2022
6 Judicial Branch American Rescue Plan Budget, provided that any amendments
7 affecting the funds or funding level shall be submitted for further prior approval
8 by the Tohono O'odham Legislative Council.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH
10 day of FEBRUARY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
11 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,
12 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
13 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
15 18, 1934 (48 Stat.984).




