

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 American Rescue Plan Act BIA Funds Budget)**

RESOLUTION NO. 22-098

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation ("Nation") received funding from the United States'**
8 **American Rescue Plan Act ("Recovery Funds") established by the American**
9 **Rescue Plan Act of 2021 ("ARP Act"); and**

10 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**
11 **2022 American Rescue Plan Act BIA Funds Budget, which is incorporated by this**
12 **reference, in the amount of \$4,431,375.50 to be funded from Recovery Funds; and**

13 **WHEREAS, the Budget and Finance Committee has reviewed FY 2022 American Rescue Plan**
14 **Act BIA Funds Budget and recommend its approval.**


15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2022 American Rescue Plan Act BIA Funds Budget effective October 1, 2021**
17 **through September 30, 2022, in the amount of \$4,431,375.50, which shall be**
18 **funded by Recovery Funds.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Nation chairperson or any designated official is authorized to administer and**
21 **expend the FY 2022 American Rescue Plan Act BIA Funds Budget for the period of**
22 **October 1, 2021 through September 30, 2022, provided that any amendments or**
23 **modifications shall be submitted for prior approval by the Tohono O'odham**
24 **Legislative Council.**


25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
26 **day of MARCH, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**




