

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 - FY 2027 San Xavier District American Rescue Plan Act Budget)**

**RESOLUTION NO. 22-104**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham,**  
2 **No district council shall expend district funds except pursuant to budgets**  
3 **authorized under resolutions of the district council and approved by the**  
4 **Tohono O'odham Council. The management of these funds shall be only by a**  
5 **treasurer or other authorized officer of the district council who has**  
6 **furnished a surety bond satisfactory to the treasurer of the Tohono O'odham**  
7 **Nation, and all expenditures of these funds shall be by checks signed by such**  
8 **treasurer or other authorized officer and the chairman or vice chairman of**  
9 **the district council.**

11 **WHEREAS, the San Xavier District applied for and was awarded funding in the amount of**  
12 **\$3,110,433.00 from the American Rescue Plan Act ("ARPA") Coronavirus Fiscal**  
13 **Relief Funds from the United States Treasury; and**

14 **WHEREAS, by San Xavier District Council Resolution No. SXDC 02-24-06, the San Xavier**  
15 **District Council has authorized its FY 2022-FY 2027 San Xavier District ARPA**  
16 **Budget, which is incorporated by this reference, in the amount of \$3,110,433.00**  
17 **that shall be funded by ARPA funds; and**

18 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2022-FY 2027 San Xavier**  
19 **District ARPA Budget and recommends approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2022-FY 2027 San Xavier District ARPA Budget in the amount of \$3,110,433.00**  
22 **effective March 11, 2021 to December 31, 2024, which shall be funded by ARPA**  
23 **Funds and which may be expended until December 31, 2026, provided that the**  
24 **funds are obligated by December 31, 2024.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022-FY 2027**  
26 **San Xavier District ARPA Budget shall be managed and expended in accordance**  
27 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**  
28 **the Nation's laws, provided that any amendments or modifications shall be**  
29 **authorized under District Council resolution and submitted for prior approval by**  
30 **the Tohono O'odham Legislative Council.**
