

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Recognition of Relinquishment from membership in the Tohono O'odham  
Nation for the month of April 2022)**

**RESOLUTION NO. 22-126**

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**  
2 **Tohono O'odham Legislative Council with the power to "enact laws and**  
3 **ordinances governing the enrollment and adoption of members and the**  
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance,**  
6 **Ordinance No. 05-81 as amended the Enrollment Committee has received a**  
7 **written statement from 03 tribal members who has expressed their intent to**  
8 **relinquish their membership with the Tohono O'odham Nation and the members**  
9 **are identified in the April 2022 Relinquishment List, which is incorporated by this**  
10 **reference; and**

11 **WHEREAS, pursuant to Article IX Section 1 of the Enrollment Ordinance,**

12 **A member of the Nation may relinquish his membership in the Nation by**  
13 **submitting a written statement clearly expressing an intent to relinquish**  
14 **his membership to the Council, a copy of which must be served on the**  
15 **committee. The written statement must be signed by the person wishing to**  
16 **relinquish his membership or, if a minor or incompetent, by the parent(s),**  
17 **guardian or other person legally authorized to act on his behalf.**  
18 **Relinquishment does not require the approval of the Council, but is**  
19 **effective upon receipt of the statement by the Council and cannot be**  
20 **subsequently denied. Upon recognition by the Council that the individual**  
21 **has renounced his membership, his name shall be deleted from the**  
22 **membership roll.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
24 **recognizes that three individuals identified in the April 2022 Relinquishment List**  
25 **has relinquished their membership in the Tohono O'odham Nation and orders**  
26 **the removal of their name from the Nation's membership roll.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
28 **day of APRIL, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,**  
30 **Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the**  
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat.984).**
