

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Department of Health and Human Services Tribal Opioid  
Response Program Budget)**

**RESOLUTION NO. 22-134**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Tohono O'odham Nation received a notice of award from the U.S. Department  
8 of Health and Human Services, Substance Abuse and Mental Health Services  
9 Administration ("SAMHSA"), for the Tribal Opioid Response Grant Program in the  
10 initial amount of \$1,400,000.00 for period of September 30, 2021 through  
11 September 29, 2023; and

12 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
13 review and approval its FY 2022 Tribal Opioid Response Program Budget in the  
14 amount of \$700,000.00 which represents one half of the allocated amount for one  
15 year and is incorporated by this reference; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
17 reviewed the FY 2022 Department of Health and Human Services Tribal Opioid  
18 Response Program Budget and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2022 Department of Health and Human Services Tribal Opioid Response  
21 Program Budget effective September 30, 2021 through September 29, 2022 in the  
22 amount of \$700,000.00 that shall be funded by the Nation's general fund pending  
23 reimbursement from the grantor, U.S. Department of Health and Human  
24 Services, Substance Abuse and Mental Health Services Administration.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
26 Nation chairperson or any designated official is authorized to administer and  
27 expend the FY 2022 Department of Health and Human Services Tribal Opioid  
28 Response Program Budget, provided that any amendments or modifications  
29 shall be submitted for prior approval by the Tohono O'odham Legislative Council.
