

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2022 Department of Health and Human Services BIA Family
Preservation Program Budget Amendment No. 1)**

RESOLUTION NO. 22-137

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the FY 2022 Department of Health and Human Services BIA Family Preservation**
8 **Program Budget in the amount of \$223,174.00 was approved by Resolution No. 21-**
9 **293; and**

10 **WHEREAS, the Federal Financial Report indicates unobligated funds in the amount of**
11 **\$140,873.63; and**

12 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
13 **review and approval its FY 2022 BIA Family Preservation Program Budget**
14 **Amendment No. 1, using 80% of the carry forward savings in the amount of**
15 **\$112,698.90, which is incorporated by this reference and which will adjust**
16 **operational and/or personnel line items; and**

17 **WHEREAS, the FY 2022 Department of Health and Human Services BIA Family Preservation**
18 **Program Budget Amendment No. 1 will increase the FY 2022 Department of**
19 **Health and Human Services BIA Family Preservation Program Budget's indirect**
20 **charges by \$11,265.18 from \$23,360.54 to \$34,625.72 and in turn increase the FY**
21 **2022 Department of Health and Human Services BIA Family Preservation Budget**
22 **by \$123,964.08 from \$223,174.00 to \$347,138.08; and**

23 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
24 **reviewed the FY 2022 Department of Health and Human Services BIA Family**
25 **Preservation Program Budget Amendment No. 1 and recommend its approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
27 **FY 2022 Department of Health and Human Services BIA Family Preservation**
28 **Program Budget Amendment No.1 effective October 1, 2021 in the amount of**
29 **\$347,138.08 that shall be funded by the Bureau of Indian Affairs.**

30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
31 **Nation chairperson or any designated official is authorized to administer and**
32 **expend the FY 2022 Department of Health and Human Services BIA Family**






