

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Public Safety Fire Department Budget Amendment No. 1)

RESOLUTION NO. 22-138

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the executive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, FY 2022 Department of Public Safety Fire Department Budget in the amount of**
8 **\$6,032,895.09 was approved by Resolution No. 21-324; and**

9 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
10 **approval its FY 2022 Fire Department Budget Amendment No. 1, which is**
11 **incorporated by this reference which will adjust operational and personnel line**
12 **items; and**

13 **WHEREAS, the FY 2022 Department of Public Safety Fire Department Budget Amendment No.**
14 **1 will not change the budget amount; and**

15 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
16 **2022 Department of Public Safety Fire Department Budget Amendment No. 1 and**
17 **recommend its approval.**


18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2022 Department of Public Safety Fire Department Budget Amendment No. 1**
20 **effective October 1, 2021, which will not change the Fire Department Budget**
21 **amount \$6,032,895.09.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend FY 2022 Department of Public Safety Fire Department Budget**
25 **Amendment No. 1 as amended provided that any amendments or modifications**
26 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
28 **day of APRIL, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;-0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**




