

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Institutional Review Board Budget)**

**RESOLUTION NO. 22-141**

1   **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2                   **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3                   **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4                   **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5                   **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6                   **Nation, Article VI, Section 1(d)(2)); and**

7   **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**  
8                   **2022 Institutional Review Board Budget, which is incorporated by this reference**  
9                   **in the amount of \$124,231.90 to be funded by the Nation's general fund; and**

10 **WHEREAS, the Institutional Review Board had sufficient members for a quorum beginning**  
11                   **June 1, 2021 and began holding Institutional Review Board meetings; and**

12 **WHEREAS, Section 8105(F) of the Nation's Research Code provides that IRB members "will be**  
13                   **paid a stipend from the Nation's Executive Office's annual budget for attending**  
14                   **IRB meetings" subject to an appropriation of funds; and**

15 **WHEREAS, without an approved budget, to date, the Institutional Review Board members**  
16                   **have not been provided a stipend to attend Institutional Review Board meetings;**  
17                   **and**

18 **WHEREAS, the FY 2022 Institutional Review Board Budget includes funds for the stipend**  
19                   **expenses incurred beginning June 1, 2021; and**

20 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
21                   **reviewed the FY 2022 Institutional Review Board Budget and recommend**  
22                   **approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
24                   **FY 2022 Institutional Review Board Budget retroactively effective October 1, 2021**  
25                   **to September 30, 2022 in the amount of \$124,231.90, which shall be funded by the**  
26                   **Nation's general fund surplus, and authorizes the expenditure of funds from the**  
27                   **FY 2022 Institutional Review Board Budget beginning June 1, 2021.**


28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
29                   **Nation chairperson or any designated official is authorized to administer and**  
30                   **expend the FY 2022 Institutional Review Board Budget, provided that any**  
31                   **amendments or modifications shall be submitted for prior approval by the**  
32                   **Tohono O'odham Legislative Council.**
