

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving and Authorizing Execution of Agreement)**


**RESOLUTION NO. 22-156**

1 **WHEREAS,** the Legislative Council is vested with the power to “consult, negotiate and  
2 conclude agreements and contracts on behalf of the Tohono O’odham Nation  
3 with Federal, State and local governments and other Indian tribes or their  
4 departments, agencies, or political subdivisions, or with private persons or  
5 organizations on all matters within the authority of the Tohono O’odham  
6 Council” (Constitution of the Tohono O’odham Nation, Article VI, Section 1(f)); and  
7 **WHEREAS,** the Legislative Council has delegated authority to the Gaming Negotiating  
8 Committee to negotiate gaming compact amendments and other agreements  
9 subject to final approval by Legislative Council resolution; and  
10 **WHEREAS,** the Gaming Negotiating Committee recommends that the Legislative Council  
11 approve the nondisclosure agreement substantially in the form presented to the  
12 Legislative Council in closed session on April 25, 2022.

13 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O’odham Legislative Council approves the  
14 nondisclosure agreement substantially in the form presented to the Legislative  
15 Council in closed session on April 25, 2022 and authorizes the Nation’s chairman  
16 and attorney general to timely execute and deliver the agreement; provided that  
17 such agreement shall remain confidential and shall not be reported or disclosed

18 The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 25<sup>TH</sup>  
19 day of APRIL, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;-0-  
20 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by,  
21 Article VI, Section 1(f) of the Constitution of the Tohono O’odham Nation, adopted by the Tohono  
22 O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
24 (48 Stat.984).


