

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2022-FY 2023 Legislative Branch Magdalena Visitor Center Project Budget)**

**RESOLUTION NO. 22-232**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Legislative Branch has prepared and submitted for review and approval its FY  
8 2022-FY 2023 Magdalena Visitor Center Project Budget, which is incorporated by  
9 this reference, in the amount of \$24,000.00; and

10 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the  
11 FY 2022-FY 2023 Legislative Branch Magdalena Visitor Center Project Budget and  
12 recommend its approval.

13 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
14 FY 2022-FY 2023 Legislative Branch Magdalena Visitor Center Project Budget  
15 effective July 1, 2022 through November 30, 2022 in the amount of \$24,000.00,  
16 which will be funded from the Nation's general fund.

17 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Legislative  
18 Council chairperson or any designated official is authorized to administer and  
19 expend the FY 2022-FY 2023 Legislative Branch Magdalena Visitor Center Project  
20 Budget, provided that any modifications shall be submitted to the Budget and  
21 Finance Committee for approval on behalf of the Legislative Council and any  
22 amendments shall be submitted for prior approval by the Tohono O'odham  
23 Legislative Council.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>  
25 day of JULY, 2022 at a meeting at which a quorum was present with a vote of 2,829.1 FOR; -0-  
26 AGAINST; -0- NOT VOTING; and 388.9[05] ABSENT, pursuant to the powers vested in the Council  
27 by, Article VI, Section 1(d)(2)and(3) the Constitution of the Tohono O'odham Nation, adopted by  
28 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
29 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
30 18, 1934 (48 Stat.984).




