

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Department of Education Child Care Services Child  
Care and Development Fund-Mandatory Carry Forward Budget)**

**RESOLUTION NO. 22-251**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and  
8 approval its FY 2022 Child Care Services Child Care and Development Fund (CCDF)  
9 Mandatory Carry Forward Budget, which is incorporated by this reference, in the  
10 amount of \$659,127.59 to be funded from the U.S. Department of Health and  
11 Human Services, Administration for Children and Families, Office of Child Care;  
12 and

13 **WHEREAS,** the Human Resources Development Committee and Budget and Finance  
14 Committee have reviewed the FY 2022 Department of Education Child Care  
15 Services CCDF- Mandatory Carry Forward Budget and recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
17 FY 2022 Department of Education Child Care Services CCDF- Mandatory Carry  
18 Forward Budget effective October 1, 2021 in amount of \$659,127.59, which shall  
19 be funded by the U.S. Department of Health and Human Services, Administration  
20 for Children and Families, Office of Child Care.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
22 Nation chairperson or any designated official is authorized to administer and  
23 expend the FY 2022 Department of Education Child Care Services Child Care and  
24 Development Fund-Mandatory Carry Forward Budget, provided that any  
25 amendments or modifications shall be submitted for prior approval by the  
26 Tohono O'odham Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>  
28 day of JULY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-  
29 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by,  
30 Article VI, Section 1(d)(2) and (3) Constitution of the Tohono O'odham Nation, adopted by the  
31 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
33 18, 1934 (48 Stat.984).






