

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Public Safety Tribal Employment Rights
Office Commission Fees Revenue Funding Budget)**

RESOLUTION NO. 22-285

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and
8 approval its FY 2023 Tribal Employment Rights Office ("TERO") Commission Fees
9 Revenue Funding Budget, which is incorporated by this reference, in the amount
10 of \$744,014.57 of which \$447,659.55 to be funded from the Nation's General Fund;
11 and \$296,355.02 is to be funded from TERO Commission miscellaneous revenue
12 funding; and

13 **WHEREAS,** the portion of the FY 2023 Department of Public Safety TERO Budget funded by the
14 Nation's general fund is addressed by separate resolution; and

15 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
16 reviewed the FY 2023 Department of Public Safety TERO Commission Fees
17 Revenue Funding Budget and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2023 Department of Public Safety TERO Commission Fees Revenue Funding
20 Budget effective October 1, 2022 in the amount of \$296,355.02, which shall be
21 funded from the TERO Commission miscellaneous revenue funding.

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
23 Nation chairperson or any designated official is authorized to administer and
24 expend the FY 2022 Department of Public Safety TERO Commission Fees Revenue
25 Funding Budget, provided that any amendments or modifications shall be
26 submitted for prior approval by the Tohono O'odham Legislative Council.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
28 **day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
