

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Legislative Branch Budget)**

RESOLUTION NO. 22-297

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Legislative Branch has prepared and submitted for review and approval its FY
8 2023 Legislative Branch Budget, which is incorporated by this reference, in the
9 amount of \$5,228,360.04 to be funded from the Nation's general fund; and


10 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Legislative Branch
11 Budget and recommends its approval.

12 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
13 FY 2023 Legislative Branch Budget effective October 1, 2022 in the amount of
14 \$5,228,360.04 which shall be funded by the Nation's general fund.

15 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
16 Legislative Council chairperson or any designated official is authorized to
17 administer and expend the FY 2023 Legislative Branch Budget, provided that any
18 modifications shall be submitted to the Budget and Finance Committee for
19 approval on behalf of the Legislative Council and amendments shall be submitted
20 for prior approval by the Tohono O'odham Legislative Council.

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
22 **day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
24 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
25 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat.984).**
