

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Division of
Family Assistance Low Income Home Energy Assistance Program ARPA Budget)

RESOLUTION NO. 22-302

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2022 Low Income Home Energy Assistance Program
9 ("LIHEAP") ARPA Budget, which is incorporated by this reference, in the amount
10 of \$26,620.00, which are funds left from the original ARPA funds of \$72,000.00
11 allocated within account number 001-22-6321-7605 that expired on June 30, 2022;
12 and

13 **WHEREAS,** the State advised that these funds can be expensed through September 30, 2022,
14 which shall be funded by the Nation's general fund pending reimbursement by
15 the grantor, the State of Arizona Department of Economic Security Division of
16 Aging and Adult Services Community Action Program; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2022 Department of Health and Human Services Division of
19 Family Assistance LIHEAP ARPA Budget and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2022 Department of Health and Human Services Division of Family Assistance
22 LIHEAP ARPA Budget effective July 1, 2022 through September 30, 2022 in the
23 amount of \$26,620.00, which shall be funded by the Nation's general fund pending
24 reimbursement by the grantor, the State of Arizona Department of Economic
25 Security Division of Aging and Adult Services Community Action Program.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 Nation chairperson or any designated official is authorized to administer and
28 expend the FY 2022 Department of Health and Human Services Division of Family
29 Assistance LIHEAP ARPA Budget, provided that any amendments or
30 modifications shall be submitted for prior approval by the Tohono O'odham
31 Legislative Council.
